FALLIS THE BEST TIME TO COME A CHIEFACT

Location: Philmont Scout Ranch is located near Cimarron, New Mexico, 45 miles southwest of Raton. Camping Headquarters is 4.6 miles south of Cimarron on Highway 21.

Who May Participate? Any individual who is at least 14 years of age or is 13 and in the 8th grade at the time of participation; units or all adult groups such as unit, district or council committee members; all participants must be registered members of the BSA.

At least two adult leaders (21 years of age or older and the other can be 18), must accompany each crew of up to 10 youths. Each coed group must have at least one adult male and one adult female leader (21 years of age or older). The **minimum** ratio of adult leaders to youth is 2 to 10. All adult groups, as well as Scout and Venturing groups, are encouraged to participate in Autumn Adventure. Many school districts have a "Fall Break" which makes it easier to involve youth. If you are an "all adult" crew, please plan to use this experience to enhance the quality of the Scouting Program in your unit and council.

Each participant must be in good physical condition. Each participant is required to have a current Level A Philmont Health and Medical form filled out by their Doctor with in 12 months of the trek and must meet the blood pressure, height and weight requirements as outlined on the Level A Philmont Health and Medical form. The nearest medical facility is 45 miles from Philmont. There is limited medical support available at Philmont during the fall program. PHILMONT REQUIRES AT LEAST ONE CREW MEMBER BE CERTIFIED IN CPR AND STANDARD FIRST AID. If you have any medical concerns, please call Philmont before your scheduled arrival day.

Crew Size: Fall camping is accomplished with a crew of 6 to 12 participants accompanied by an Autumn Adventure Guide. Larger groups are organized into multiple crews (minimum crew size 6, maximum crew size 12 - **No Exceptions**).

Fees: \$40/person/day which includes trail food and staff guide with each crew. The guide will help your group plan an itinerary and accompany you on your trek.

Reservations: Reservations are confirmed upon receipt of a \$50/person deposit with the reservation form. All fees are non-refundable or transferable to the balance in the event of cancellation. Call 575-376-2281 to determine when space is available.

Arrival/Departure: Arrive and depart any day during Autumn Adventure. Depending on your crews schedule your arrival and departure days may be considered full or half days, with a half day fee at \$20.00/person. If arriving late in the day, try to do so between 6:00 - 7:00 pm. You will be housed in Camping Headquarters Tent City the first night. EVENING MEAL WILL NOT BE SERVED. The Philmont dinning hall is not available for crews during the autumn. Plan to eat supper before arriving at Philmont. If you arrive in the morning, you may get into the backcountry that same day. 10x12 wall tents with cots are available at Camping Headquarters for your first and last nights at Philmont if you need them.

Program Options: Each group will plan its own itinerary with the assistance of an Autumn Adventure Guide. The itinerary can be as strenuous or as leisurely as desired depending upon the physical condition, training and preparation of the group. A guide will accompany each group throughout its trek. Accommodations to stay at Headquarters are not available except for your first and last night and there is **NO MEAL SERVICE**.

All groups must camp in the backcountry. The group may elect to take day hikes from their backcountry site or camp in different sites each night. Opportunities abound for photography, trout fishing, mountain climbing, gazing at wildlife, learning about the flora and fauna of the area, visiting historical sites or just relishing the opportunity for quality time away from the stress of every day life.

Philmont will NOT provide transportation to backcountry camps, but will provide transportation to designated turnarounds. (Turnarounds: Zastrow/Abreu, Lovers Leap, Cimarroncito, Six Mile, Ponil and Maxwell.) In the past we have made exceptions to this rule, with the growing popularity of the program we will not be able to make those exceptions. Philmont will assist you in shuttling your personal vehicles to your selected ending point.

Fishing: September 9th through September 12th Philmont hosts a large Fly Fishing Invitational to benefit local councils. During that time Autumn Adventure crews are not allowed to fish on the Rayado River or in the Cimarroncito Reservoir. Camping is also not allowed at Abreu, Zastrow, Fish Camp, Phillips Junction and the Hunting Lodge during this period. Autumn Adventure Crews are welcome to fish during the rest of Autumn Adventure. Non-resident fishing licenses must be purchased for each person who wants to fish at the following rates: (subject to change) 1 day license - \$17.00; 5 day license - \$29.00; annual license \$61.00. Philmont fishing licenses for persons under 17 may be purchased for \$1.50. This is the 2009 price structure, 2010 prices will be determined by New Mexico Game and Fish in March of 2010.

Leave No Trace: The Autumn Adventure program will host a Leave No Trace Master Educator Course during the first part of October. If you are interested contact Philmont for detailed information and the registration form. (**Please note:** Philmont LNT Master Educator course registration form is different than this standard Autumn Adventure registration form.)

Awards: Each participant who completes training will be awarded a distinctive Autumn Adventure patch as a remembrance of Philmont Autumn Adventure. The patch can only be earned; it is a recognized symbol of participation in a fall trek.

Tour Permit: Submit your tour permit for approval at least one month in advance. You will need a tour permit even if your crew is an all adult group.

Transportation: Check your vehicles BEFORE you leave home. AAA and state agencies will recommend emergency supplies you should carry.

Trading Post: The Tooth of Time Traders will be open 8 to 5 seven days a week during the Autumn Adventure period. You can also place orders online at www.toothoftimetraders.com.

Clothing and Equipment: When packing for Autumn Adventure, consider protection for each part of your body. Temperatures may vary from 80 degrees F during the day to 20 degrees F or even lower at night.

Whenever possible, bring clothing made of wool, polar fleece or polypropylene. Even when wet, these fabrics retain some insulating value. Each participant should bring or plan to buy the following: (items marked with an * can be purchased in the Tooth of Time Traders)

RISK ADVISORY - PHILMONT SCOUT RANCH

Philmont has an excellent health and safety record with over 910,000 adults and young people having attended since 1938. Philmont strives to minimize risks to participants and advisors by emphasizing proper safety precautions. Most participants in Philmont programs do not experience injuries because they are prepared, are conscious of risks, and take safety precautions. If you decide to attend Philmont, you should be physically fit, have proper clothing and equipment, be willing to follow instructions and work as a team with your crew and take responsibility for your own health and safety. For further information please thoroughly read the *Guidebook to Adventure*. Like other wilderness areas, Philmont is not risk free and you should be prepared to listen to safety instructions carefully, follow directions and take appropriate steps to safeguard yourself and others. appropriate steps to safeguard yourself and others.

Parents, guardians and potential participants in Philmont programs are advised that journeying to and from Philmont, and one's stay at Philmont, can involve exposure to accident, illness, and/or injury associated with a high elevation, physically demanding, high adventure program in a remote mountainous area. Campers may be exposed to occasional severe weather conditions such as lightning, hail, flash floods and heat. Other potential problems include: injuries from tripping and falling, motor vehicle accidents, worsening of underlying medical conditions such as diabetes or asthma, heart attacks, heat exhaustion and falls from horses.

Philmont's trails are steep and rocky. Wild animals such as bears, rattlesnakes and mountain lions are native and usually present little danger if proper precautions are taken. Please refer to the *Guidebook to Adventure*, speak with previous Philmont participants, or call Philmont for further information concerning risks and measures which can be taken to avoid accidents. Philmont has staff trained in first aid, CPR and accident prevention, and is prepared to assist in recognizing, reacting, and responding to accidents, injuries and illnesses. Each crew is also required to have at least one member trained in wilderness first aid and CPR. Medical and search and rescue services are provided by Philmont in response to an accident or emergency. However, response times can be affected by location, weather or other emergencies and could be delayed six (6) or more hours.

PHILMONT WEIGHT LIMITS FOR BACKPACKING AND HIKING

Each participant in the Backpacking ME course must not exceed the maximum acceptable limit in the weight for height chart shown below. The right hand column shows the maximum acceptable weight for a person's height in order to participate in a Philmont trek. Those who fall within the limits are more likely to have an enjoyable trek and avoid incurring health risks. These guidelines are used because overweight individuals are at a greater risk for heart disease, high blood pressure, stroke, altitude illness, sleep problems and injury.

Participants 21 years and older who exceed the maximum acceptable weight limit for their height at the Philmont medical recheck WILL NOT be permitted to backpack or hike at Philmont. For example, a person 70 inches tall cannot weigh more than 226 lbs. All heights and weights will be measured in stocking feet.

For participants under 21 years of age who exceed the maximum acceptable weight for height, the Philmont physicians will use their best professional judgment in determining participation in a Philmont trek. Participants under 21 years of age are strongly encouraged to meet the weight limit for their height. Exceptions are not made automatically and discussion in advance with Philmont is required regarding any exception to the weight limit for persons under 21 years of age, whether it is over or under. Philmont will consider up to 20 lbs. over the maximum acceptable as stated on the chart, however, the exception will never exceed 295 lbs. Philmont's phone number is 575-376-2281.

The maximum weight for any participant in a Cavalcade Trek and for horse rides is 200 lbs. Under no circumstances will any individual weighing more than 295 pounds be permitted to participate in backcountry programs. This requirement is necessary because of limitations of rescue equipment and for safety of search and rescue personnel.

Individuals who do not meet Philmont's weight for height requirements will not be allowed on the trail and will be sent home.

This table is based on the revised Dietary Guidelines for Americans from the U.S. Dept. of Agriculture and the Dept. of Health & Human Services.

A water-displacement test to determine percent body fat will also be accepted in lieu of the height-weight guidelines. Women will need to have a body fat of 20% or less and men will need to have a body fat of 15% or less to be qualified to participate. No other form of test to determine percent body fat (DEXA scan, skin fold, etc.) will accepted by Philmont.
